Announcement

In the fall of 1880 there was inaugurated in Omaha a preparatory school under the name of the "Nebraska School of Medicine." Instruction was given for five months with a complete course of lectures in the different departments of medicine and surgery. The success of the school far exceeded the most sanguine expectations of its founders and convinced them that a well equipped medical college is actually demanded by the rapidly increasing population of Nebraska and contiguous states and territories. With this experience the faculty in May 1881 organized and incorporated under the law of Nebraska the Omaha Medical College. In sending forth this the 2nd annual announcement it is with pleasure they can assure the profession and students of medicine in the territory tributary to Omaha.
