I. INTRODUCTION

.

The <u>purpose</u> of this paper is to present a comprehensive survey of the mental health resources as reflected through agents and agencies utilized for the care, treatment and rehabilitation of the mentally ill in Nebraska. From the beginning, this project has had another purpose in addition to that of fulfilling the thesis requirement for the doctorate degree. This is the compilation of a reference source for mental health resources in Nebraska, of which none exists at the time of this writing.

It is hoped that the information collected can be incorporated into a handbook for distribution in the State to doctors and welfare agencies to whom such a reference would be of value.

The <u>scope</u> of this paper then must include resources from the national level down, which play a direct part as mental health resources in the state.

There are <u>limits</u>, in that only agencies which have physical units in the state, or which give direct service to patients, are described in detail. Therefore, only addresses of many national groups are given. Cutlines of organizations of national and state agencies, in some cases, have been given to show more clearly how they are utilized as mental health resources. There are local groups which exist as autonomous organizations, and are

excluded only because they have not been "found".

Errors are inevitable. They have been eliminated as best possible.

Recognition and thanks are given to Doctor T. P. Krush and his Community Services Staff, Nebraska Psychiatric Institute for their tremendous support, and guidance; and to the National Institutes of Mental Health for a summer grant that made much of the work financially feasible.

Rationale The question will undoubtedly rise, as to the validity of including some of the resources listed as mental health resources. It is to be remembered that the care of a mentally ill person is a complex operation with the need for integration of many services which may not be primarily mental health facilities. The following rationalization may be helpful:

Facilities for the blind are included because of the frequency for need of these people for psychiatric and psychological help.

Child placing organizations are included, because of the not infrequent need to keep a child out of a poor mental health environment, and place him in more healthful surroundings.

Counseling facilities need no explanation.

Services for the deaf are included for the same reason that services for the blind are included.

Foster care homes and/or residences are included, because of the need to take care of children while a lone parent is being treated for psychiatric conditions.

Maternity homes are included in order to complete the care needed by these unfortunate girls.

Speech services, vocational rehabilitation, and physically handicapped facilities are included in order to treat the whole patient.

Nursing homes are continually coming into, and going out of existance. In order to obtain an up to date list, one should write to the Office of Information and Service, the State Department of Welfare, Lincoln, Nebraska.

II. DATA COLLECTION

Method of Data Collection

Since no complete directory of agencies exists, the agencies were "found" in partial listings in various books and pamphlets (2,3,4,5,7,8,9, and 10) and personal contacts.

As much information was collected on each agency as possible. Then the agency was sent a letter of explanation, and a questionnaire. The questionnaire was completed with as much information as was available from the references. As can be expected, a considerable bit of this information was incorrect, or out of date. And, as can be expected, each group was prompt in correcting, completing, and returning the questionnaires.

The State agencies were visited personally to gain information which was not applicable to the questionnaire form.

The information was then transferred and summarized on an outline (p. 11). It is in this form that the information appears in section VI. (Information on Agencies)

Response to Questionnaires.

The response was prompt with _73 letters completed and returned out of 89 sent. There were 16 not returned with _2 agencies no longer in existence.

COMMITMENT PROCEDURES

Commitment to a State mental hospital can be carried out in any one of three ways. They are:

1. Commitment from County Board of Mental Health.

The County Board, composed of a physician, a lawyer and the clerk of the district court (excfficio), in the presence of the judge of the district court, receives all applications for admission to mental hospitals except voluntary admission and certification.

The Board decides if the patient is mentally ill, and if so, commits him to the hospital. If the state hospital is unable to receive the patient, the County Board of Mental Health is responsible for him. The Board may authorize relatives or friends to care for him. The patient may be transferred to the state hospital at anytime within six months without further hearing. The Board may have any patient released if they believe he has recovered.

2. Voluntary Admission to State Hospital.

A patient may voluntarily enter a state hospital after direct contact with the superintendent. He must be released in ten days after written notice to the superintendent unless the County Board of Mental Health so acts as to commit him.

3. Certification by Two Physicians

Upon the written application of a friend or relative, and the accompanying certification of two licensed physicians, the superintendent may receive a patient. The patient will be granted a release upon request, unless he is then committed by the County Board of Mental Health.

Purpose: To provide an institution for the care of the mentally defective.

Services: Residence for the feeble minded, educational program, music program, occupational therapy, training school, school for the blind, social service is available, diagnosis; treatment, and evaluation of patients at admission, and periodically thereafter.

Eligibility: All ages are acceptable, if they are residents of Nebraska. They must he adjudged a mental defective by county court on statement to court by a physician and a psychologist.

Fee:

General: The Home is under the auspices of Board of Control, and is tax supported. There are 15 ward buildings, a general hospital, school and auditorium on the 649 acres of land. The capacity is 2394. The staff consists of 1 consultant psychiatrist, 2 parttime physicians, and 1 full-time dentist, 1 part time and 3 student part-time psychologists, 9 nurses, 17 instructors, a laboratory technician, x-ray technician radiologist. Education, training, and custodial care for all ages and both sexes is provided. The institution is inspected by state Fire Marshall and the Nebraska Department of Health. Descriptive literature is available.

Admittance procedure: Petition to Nebraska court. County Welfare Department handles correspondence to Beatrice State Home. The waiting list is long.

Bethphage Mission Axtell, Nebraska SH 3-4611 Chief Administrator: Director Office Hours:8:00a.m.-4:00p.m., Monday through Friday; Saturday, 8:00a.m.-12:00 Noon.

Purpose: Custodial care home for the mentally and physically handicapped, noneducable, and lower-level trainable children.

Services: Custodial care for physically and mentally handicapped people.

Eligibility: Boys and girls, 2 years old and older are accepted. Legal residence must be established prior to admission. The only other requirement is that they must be docile.

Fee: \$125.00/month

General: The Mission is under the Evangelical Lutheran Augustana Synod, and supported by it, and tuition. There are 5 care homes. The Mission is licensed for 40 children and 199 adults. The staff consists of a part-time psychiatrist (from Nebraska Mental Hygiene Clinic), 9 part-time physicians, a part-time psychologist, a part-time nurse, and a faculty of 2. Descriptive literature is available.

Admittance procedure: Contact Director, Bethphage Mission, Axtell, Nebraska. The waiting list is long.

Purpose: To train and prepare delinquent boys to go back into society in order that they might become useful citizens.

Services: Supervision, guidance and rehabilitation includes psychological testing, counseling, job training, academic schooling and research.

Eligibility: Males to 18 years of age (on admittance) who have committed delinquencies in Nebraska, regardless of residence, are accepted. Also the School receives juvenile Federal offenders under Federal contract.

General: Under the auspices of the Department of Institutions, the School is tax supported. Land includes 600 acres, of which 300 are irrigated farm lands. The 250-boy capacity is housed in cottages of 6 boys each. The staff includes a part-time psychiatrist, a part-time physician, a part-time psychologist, and 21 instructors. Descriptive literature is available.

Admittance procedure: The boy is accepted on presentation of a court order by sheriff who delivers the boy to the school.

SUMMARY

The foregoing has been an attempt to compile information on all the agencies concerned with problems of mental health of the people of Nebraska. The information has been divided into Federal, State, County, and Local sections.

Federal data includes a list of national associations concerned with mental health, and an outline of the Department of Health, Education and Welfare, to demonstrate its contributions to mental health.

The State data includes a brief discussion, and outline of the Department of Education, Department of Health, Department of Institutions and Department of Public Welfare, to demonstrate how each plays a part in the various programs related to mental health.

The County data consists of a discussion of various commitment procedures to State Hospitals.

Information on local agencies was gathered, for the most part, by mail questionnaires, with the remainder of information gathered by personal contact. Of the 89 questionnaires sent, 73 were returned, 16 not returned, and 2 agencies were found to no longer exist.

The data on each agency includes address and phone, administrator's title, purpose, services offered, fees,

general data and admittance procedure. The agencies are classified by alphabet, cities and services.

No attempt has been made to analyze the adequacy or need for these resources. It is hoped that this information as a reference source will be of assistance to doctors, welfare workers, and others in the state who are called upon to use the agencies in the prevention of mental health problems, and the treatment and rehabilitation of patients with these problems.

General: The Center is under the auspices of the National Foundation (p. 102), and supported by contributions to the Foundation. Other similar centers are located in Seattle, Washington D. C., Baltimore and Jacksonville. An evaluation clinic is held the third Thursday of each month. The staff includes at present, an orthopedic surgeon, neuro-surgeon, pediatrician and medical social worker.

The facilities of the Children's Memorial Hospital are used for the evaluations and treatment. At present the medical social worker's office there, is the office for the Center.

Hospital costs are covered when: 1-The patient cannot afford such expense. 2-The defect is congenital. 3-Disability can be reduced or prevented. 4- The patient is not in an institution for retarded children. 5- The patient is not eligible for adequate services provided by other agencies.

Descriptive literature is not yet available.
